- For any complaints related to the following cases:
 - Complaints concerning the observance of the provisions of the Insurance Code and its implementing rules:
 - Complaints for which the complainant is not satisfied with the outcome of the complaint, as well as those to which the Insurer did not reply within a maximum period of 45 days following the date of receipt, including those relating to the management of the contractual relationship (particularly in terms of the attribution of responsibility, the effectiveness of the provision, quantification and payment of sums due to the person entitled).
